part thereof might be converted, invested or varied from time to time or which may be acquired by the Trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the Trustees shall hold and stand possessed of the same upon the Trust objects to the powers, provisions, agreements and declarations hereinafter contained.

1. **Name** : The name of the trust shall be "S.D. Educational Foundation & Welfare Trust", (Hereinafter know as Trust). The trustees may change it. If they mutually so decided in future.

2. **Registered Office**: The registered office of the Trust shall be located In Paliganj at Patna district and at present shall be placed at Vill.- Dharhara, P.O.-Paliganj, P.S.-Paliganj, Dist.-Patna (Bihar) and it can be changed at such other places as the Board of Trustees may decide from time to time.

3. **Area of Operation**: The operational area of the Trust shall be whole India and may be reduced as the Trustees may decide.

4. **Administrative Office, Branches or Project Offices**: Trust may have administrative office or branches or project offices in such place or places as decided by the Chairperson of Trust or Board of Trustees time to time within the operational area of the Trust under the overall guidance and control of the registered office.

5. **Funds of the Trust**: The assets, together with all further donations, contributions, grant and loan in any shape or form made to the said trust from time to time, and the rents, profits and income thereof and the stocks, funds and properties representing the same shall be held by the Trustees upon Trust for the objects and purposes and subject to powers and provisions hereinafter set out.

6. **Objects of the Trust:**

Trust will extend its services without discriminating the caste, creed, race and religion but special emphasis will be on educationally backward in particular and weaker sections in general. The objects of Trust are to:

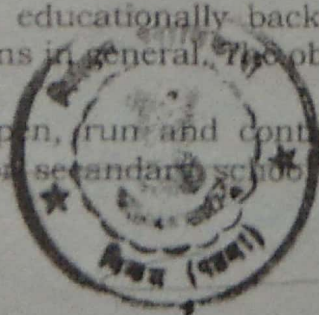

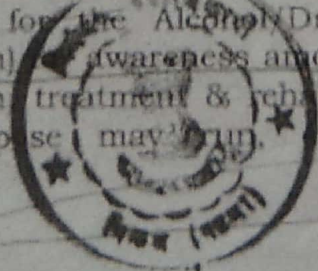

- Dramatic, film making, acting and performing art and audio-visual screening process technique.
- Rain water harvesting and watershed management.
- 6.13 Promote or organize or implement activities for the promotion of cultivation of aromatic and medical plants, horticulture, social forestry and forest expansion.
- 6.14 Make efforts for information dissemination, R&D, to expedite the non-conventional source of energy.
- 6.15 Promote and execute activities like sanitation, water supply, rural health, construction of road and other activities for rural development whenever necessary.
- 6.16 Promote, produce, sale and advertise Khadi products and village industries as approved by Khadi & Village Industries-Commission.
- 6.17 Promote, produce, sale and advertise audio-visual software film for furtherance of aforesaid objects.
- 6.18 To work in the field of mental health management, its awareness, treatment & rehabilitation of the person suffering from it.
- 6.19 To run, establish, maintain or acquire a Mental Hospital or clinic, psychotherapy centre, psychometric centre, social medicine centre, Rehabilitation home, after care home, laboratories etc.
- 6.20 To establish, hire purchase, acquire, run maintain, own any X-Ray plant, C.T. Scan, M.R.I, E.C.T, E.E.G, E.C.G and pathological Test centre.
- 6.21 To work for Social empowerment of person and community by Medical, Educational, Financial and other resources.
- 6.22 To work for the benefit of street/orphan children, hawkers, Bidi workers, factory workers, cottage, small, medium and big industries workers, employed women, weaker and minorities persons, and other communities of these type and rehabilitation of commercial sex workers.
- 6.23 To work for the Alcohol/Drug de-addiction (drug abuse prevention) awareness among masses and also work on prevention treatment & rehabilitation programme and for this purpose may run, establish, maintain, acquire

- 6.24 To establish, maintain, run, acquire, develop, improve, extent, grant, donate for and to aid and assist in the establishment, maintenance, running, development, improvement and extension of General hospital, Nursing home, clinic, X-Rays plants, dispensaries, maternity home, recreation centre and all similar institutions.
- 6.25 To run, maintain, establish, own, manage any Rehabilitation centre in the following field:
- Any type of handicapped persons.
 - Orphans persons.
 - Weaker section/class of persons and Communities.
 - Mentally retarded persons.
 - People suffering from Leprosy.
 - Socially deserted people.
- 6.26 To charge tuition fee/fees and otherwise recoup themselves for the outlay and expenses incurred in the up keeping and maintenance of institution established or to be established by the Trust.
- 6.27 To conduct poor feeding and generally give food and relief to the poor needy and disable person and to afford relief work to people in distress due to natural calamity, accident, earthquake, flood, famine, epidemics and grant donation for the support of orphanage and welfare institution and may also carry on rehabilitation programmes.
- 6.28 To carry on community development programmes for the up-liftment of the economically weaker section of the society and also construct and develop community centre or hall for carrying such activities.
- 6.29 Provide consultancy, placement and advisory services, undertake all acts, deeds and things connected with incidental to and germane to the aforesaid objects.

7. Board of Trustees:

The Trust shall be vested in a Board of Trustees (hereinafter called the Board) which shall consist of not less than five and not more than seven trustees. The first Trustees constituting the Board are:

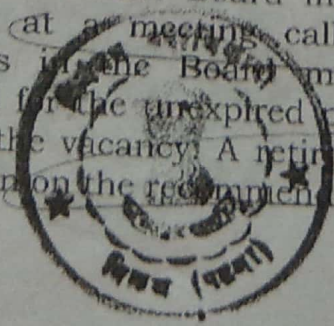

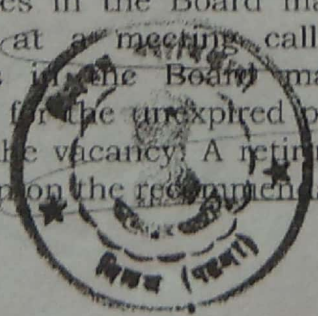

- 7.7 The quorum for a meeting of the Board shall be 1/3rd of the existing members. If the meeting have not a quorum within one hour of the fixed time, the meeting shall be adjourned to the same day and time at the same place for the next week. Adjourned meeting shall not require having a quorum.
- 7.8 Vacancies in the Board shall not invalidate the any of the proceedings of the Board.
- 7.9 The Board may meet as often as necessary but not less than twice in a calendar year and their proceeding shall be recorded regularly in minute's book to retain for purpose. In any resolution to be passed touching the administration of the Trust, the opinion of the majority shall prevail. It shall be competent however for the Trustee to decide matters by circulation. In case there being equality of votes, the chairman of the meeting has casting votes for the purpose of deciding the issue.
- 7.10 Decisions at the meeting of the Board shall be taken by the majority of the trustees present by unanimous decision or voting. In the case of equality of votes, the Chairman of the Board shall have a second or casting vote.
- 7.11 The founder shall also be one of the trustees during his life and after the death the eldest male member of his family shall be a co-trustee.
- 7.12 The trustee may frame rule and regulation as to the duties and responsibilities of each Trustee, to appoint sub committees with the administration of the Trust and its management.
- 7.13 The managing Trustee or his nominee or any other Trustee so authorised by the board of trustees shall have the custody of all the document, deeds, titles relating to the Trust properties and investment, and the book of account and other records relating to the Trust and shall be responsible to the preservation of the same.
- 7.14 Notice shall be served personally or sent by post to the Board of Trustees seven days prior for all type of meetings.

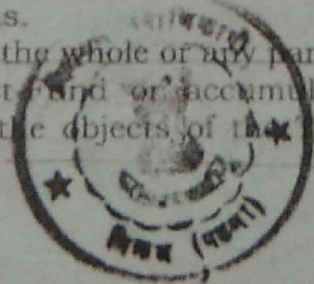

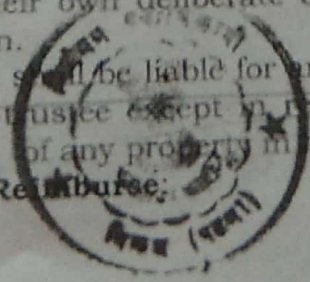
11 Indemnity :

Subject as aforesaid the terms of this deed may be amended, altered or modified by a majority of 2/3rd members of the Board present and voting in a meeting called for the purpose.

Provided, however, that no amendment contrary to the objects of the Trust hereinbefore set forth shall be valid and effective.

That in case of any disputes as regarding interpretation of any terms of this **DEED OF TRUST** among the Trustee, or between any Trustees and the Managing Trustee it shall be solved as per the provision of the INDIAN Registration Trust Act, 1882.

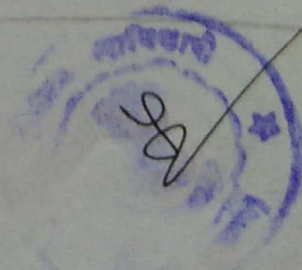
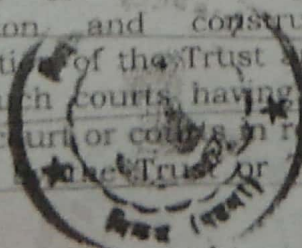
17 Advisory Body:

connected therewith, the competent courts in Patna (Bihar), shall have jurisdiction to entertain, try and determine such claim or dispute in exclusion of such other court or courts.

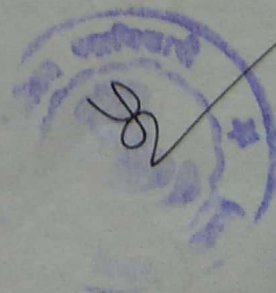
